assistant manager, and Shanna drive the neighborhood once a day to check on progress and see any other violations there might be to report.

#### Old business:

Roof updates- Roof replacement started late due to weather. The pool bathhouse and clubhouse are now finished.

Ceiling & Flooring-This work will be done to remove the ceilings and flooring damaged by the flooding.

#### Timeline:

HVAC-This will be replaced as the renovations get underway.

MOLD-Mold remediation will begin August 21st.

#### **New Business:**

Office Renovations-These renovations will start as soon as mold remediation is complete. Areas will be sealed off so the effected areas can be ripped out and disinfected.

Pool Update-All pool pump equipment is now in working order and the pump house has been fully cleaned and redone. The pool is working, and daily chemical checks and cleaning are ongoing.

Coquina-The coquina chimney was removed. The coquina was very unstable. We saved as much as we could, and it is being stored on the property. We will use the pieces as accents around the clubhouse and community. The new chimney will have a stucco finish with new paint.

## Committee Reports:

ACC-no report given.

The Building & Grounds-Report was given on the crosswalk at Deltona Blvd at Aragon Park. The Beautification Committee was out there and trimmed a bush so oncoming traffic had a better view of the people crossing. At that sidewalk, volunteers also shoveled the sand off the crosswalk and then blew off the rest. The railroad ties that are there still don't prevent some of the sand from gathering, but its much better than it was.

Communications-Second newsletter has been distributed and the next one is in the works.

Director Comments-Nicolas Arocha gave an update on the drainage issues currently around the neighborhood. He has a good contact at the County and will be working closely with them.

Membership Comments-RV Compound questions were asked about fees going up. That area has to be maintained and all costs are going up for that as well. It is still a reasonable increase for our residents compared to outside the neighborhood storage facilities. A question was brought up on closed
